

## Comments from the Board Chair and the Executive Director

An increasing wealth gap, haves and have-nots, and segregation by class—these are some of the terms we hear every day that offer a description of American society. But here in Orange County, North Carolina, a new trend has emerged in the past several years—a trend toward inclusiveness in the housing arena.

Initiated by the Chapel Hill Town Council, the policy of inclusionary housing has resulted in 67 affordable homes being approved in the past four years. The Council asks that all new developments include 15 percent affordable homes. These homes are affordable to municipal employees, teachers, UNC employees, and others who too frequently are unable to own a home near where they work. When placed in the Land Trust, these homes remain affordable forever to the individuals and families who will need affordable housing in the decades ahead.

These homes are located in such upscale communities as Meadowmont and Larkspur, and can also be found in Vineyard Square and on Milton Avenue. Better yet, we'll soon have affordable homes in Winmore and Pacifica in Carrboro and in Waterstone in Hillsborough. Building affordable homes (priced between \$80,000 and \$130,000) in these neighborhoods enables core employees of our community to live in Orange County, send their kids to our schools, and enjoy a higher quality of life.

The board and staff of Orange Community Housing and Land Trust devote great effort to making this concept of inclusivity work for the families that purchase Land Trust properties. As an organization, we continue to learn and do a better job of meeting the needs of our homeowners. This would not be possible without the financial support and encouragement we receive from our elected officials. Nor would it be possible without the willingness of private sector developers to partner with us to provide the housing. To all of you in the public and private sector who have contributed toward inclusiveness, we offer our heartfelt thanks.


