In June, Sales and Marketing Manager Crystal Fisher and Project Manager Christine Westfall were invited to speak about The Land Trust on The People's Channel. Christine spoke about The Land Trust's origins as a government funded non-profit and its incorporation in 1999 into what is now Orange Community Housing and Land Trust. She explained that the land trust model offers a viable option for low to middle income families, particularly in Chapel Hill and Carrboro where homes are so expensive. "Keeping these homes forever affordable is one of the challenges facing The Land Trust." Crystal spoke about the homeownership program, its guidelines and income requirements and about The Land Trust's ongoing homebuyer education programs. "The Land Trust offers an opportunity for first-time homebuyers to build equity and achieve a measure of self-sufficiency."

FIRST N.C. COMMUNITY LAND TRUST CONFERENCE

Draws Attendees From 9 Southeastern States



More than 125 people from NC and eight other states attended our two-day conference in April to learn about how the Community Land Trust (CLT) Model could work in their communities. Housing and non-profit organizations are studying the CLT model for its permanent affordability aspect. We were very fortunate to have John Davis and Mary O'Hara from Burlington Associates speak about the history of the CLT movement and its relevance and impact in our communities today. The conference was largely underwritten by a federal grant provided by Congressman David Price who addressed conference participants during one of the conference sessions. A highlight of the conference was a chartered bus tour of Land Trust properties throughout Chapel Hill and Durham. Conference sponsors included Neighborworks, SunTrust, The CLT Network and the North Carolina Community Development Initiative.
